# Phase One (Concurrent)

- Conduct Survey of Tomah Employees
  - Verify significance of childcare as a workforce issue
  - Quantify need for childcare services
  - Collect info about areas of highest need (i.e. infant, overnight, summer, etc.)
- Learn About Tomah Business Community's Childcare Perception/Action
  - Learn what, if anything, businesses are currently doing to aid employees w/ childcare
  - Synthesize any existing data businesses have on employee childcare need
  - Gauge business interest in participating in a childcare solution for their employees
- Prepare Inventory of Existing Childcare Facilities in Tomah
  - Identify existing childcare facilities serving Tomah
  - Identify capacity/interest of existing providers in expansion
  - Learn about current, local challenges in the industry




# Survey of Employees

Received no printed completed surveys – only digital responses





If you don't have regulated childcare, do your children attend child care such as a family, friend or neighbor? (Paid or Unpaid?)






## How many children do you have in childcare?

# What are the ages of the children that you have in child care?




# How many hours per week, on average, do your children attend childcare?

- Grandparents, Neighbors, Friends




If you work non-traditional hours (ex: swing shift, night shift, etc.), how do you coordinate childcare for these hours?

- "Due to childcare costs and lack of availability of childcare centers, I work only 1 day per week as my mother-in-law is only available to watch the child one day per week."
- Mother In Law watches him for now. BUT when she decides not to will not have anybody else."
- "I work night shift. On Mondays, Wednesdays, and Fridays, my oldest will go to daycare from8am to 12. My youngest has no childcare and stays with me. He takes a 1.5 hour nap around 9. That is when I sleep, otherwise I dont."
- "I have changed my career to fit traditional daycare hours"




## If you have school aged children, do you need / are you interested in afterschool or summer care?






# Do you utilize childcare in the City of Tomah?






# Are you utilizing multiple childcare providers simultaneously?









How many childcare providers have you used from the time your child was born until the time they entered kindergarten?




Do you travel more than 10 miles outside the route of your daily commute to reach your child care provider?






# Do you receive Wisconsin Shares benefits for childcare?



Quit my employment and became a stay at home parent	5.56%





# How many lost hours of work have you had due to lack of childcare in the last 6 months?








# "I can rely on my childcare provider to be there when I need them so I don't have to miss work"






# Which of the following have been challenges in finding childcare that meets your needs?

### **Respondent Suggestions**

- "Provide funds toward an additional facility to increase capacity; provide pooled funds to decrease costs for all families (or those under a certain income limit)"
- "Maintain cost effectiveness and ensure SAFE provider to child ratios."
- "Help increase the number of childcare center daycares within the city of Tomah. They are very hard to get into with very long wait times, especially for infants."
- "Provide more options at an affordable cost."
- Making sure there is QUALITY care where I don't need to worry if my child is taken care of. AFFORDABLE"



#### **Respondent Suggestions**

- Increase the amount of service providers for childcare by providing funding and locations for daycares. Provide a financial assistance for those utilizing daycare to offset the considerable amount of the paycheck that goes towards daycare, as this could help us keep working."
- "Provide a stipend or some sort of cost share as a benefit to reduce childcare expense. Or create another daycare center (certified and with respectable staff) to eliminate the risk of missing work because an in home daycare has to close due to schedules/illness, etc."

### Other Comments

- "My daughter was asked to leave 3 separate in home daycares due to her <u>disability and special needs</u>"
- "Tomah has a round the clock workforce of families which contribute to the community. Yet, the infrastructure of the town is not gauged towards them. There is a significant gap in care in this community for the most important part of the community, the kids. Parents having to shuffle between which in home daycare is the least worst in order to keep coverage. Leaving the weight on extended family or having to miss work due to lack of GOOD care."
- "In the past childcare greatly impacted my stress level, finances, and overall led to my husband and I intentionally working opposite shifts to limits our need for child care. <u>This also directly impacted our</u> <u>decision to have more children an grow our family.</u>"

# Findings

- All group centers operating below full capacity due to staffing shortages
- All in home providers were full with a wait list
- In home providers experiencing landlord / banking challenges
- Stressed importance of state-level advocacy for policy change
- "No incentive to be regulated"
- Strong network of regulated in home providers that collaborate
- Infant care challenges



# Findings

Consistent with other communities:

- High regulatory burden
- Hard work
- Low pay
- Little external support
- Workforce shortages
- Need for additional support (financial, administrative, etc.)
  - La Crosse County, Jackson County, etc.

# Phase Two (Sequential)

- 1. Produce a brief report synthesizing info from phase 1
  - Share back to business + community members via a meeting or open forum
  - Gather feedback and question on findings; Gauge willingness for engagement
- 2. Develop a committed group of stakeholders willing to co-create a childcare solution for Tomah
- 3. Align info from Phase 1 report with childcare best practices, models, examples, etc.
  - Conduct, as necessary, outreach to other community/orgs who have implemented aligned solutions to learn more
  - Research potential solutions, best practices, etc.
- 4. Prepare a recommended action plan as a group and transition into implementation
